

ANDEN UPDATE

The City of Warrenville is proceeding with strong action against the Anden/ESR Corporation to assure that the River Oaks public improvements and landscaping promised by Anden and required by City ordinance are completed. The chronology of significant events since the last Newsletter update follows:

January 29 City Public Works Meeting. The City indicated that Anden had not responded to their letters, and that possible legal action against Anden would be discussed at the February 4 City Council meeting.

February 4 City Council Meeting. Alderman Brian Aschauer, reporting on Public Works deliberations regarding the River Oaks problems, stated "I think these people need our help ... this could drag on and on" (if the City didn't come to River Oaks' aid). Aschauer moved to instruct the City Attorney to direct legal action against Anden if a satisfactory response from Anden did not arrive by February 11. Alderman Dave Carroll stated his strong support of River Oaks, claiming that


Anden had been totally remiss in addressing the promised improvements. Alderman Glenn Ulery seconded Aschauer's motion, and the motion was carried by an 8-0 vote! City Attorney Barry Moss told Board member John Christiansen that the City intended to go after every item in the City Engineer's report, and every other River Oaks issue of a public nature, in the lawsuit. Moss advised us to have our attorney coordinate details of the suit with him.

February 21 Talk with River Oaks Attorney. Our attorney, Joe Ricely, reported that he had just talked to City Attorney Moss. Moss stated that he had begun drafting the complaint against Anden. City Administrator Jim Connors and City Engineer Ken Carnignani met on February 19 to determine how much public improvement work had actually been done satisfactorily by Anden. Moss estimated that suit would be filed within about two weeks. The suit will include all previously identified public improvements and all landscaping provisions of City Ordinance 828. Regarding strategy for the lawsuit, Moss preferred that River Oaks not appear as co-plaintiffs when the City suit is filed. However, Moss had no objection to River Oaks asking the judge to be co-plaintiffs after the suit is filed. Ricely's advice is for River Oaks to get a copy of the City suit when it is filed, and take separate legal action only if we feel that the City has left out some really critical issues.

February 26 City Public Works Meeting. The City reported on a meeting it had had earlier in the week with Anden representatives. Alderman Aschauer indicated that Anden had contributed nothing of substance at the meeting, and that the City had not changed its mind at all about the lawsuit. City Administrator Connors stated that Anden had asked for a reprieve, but that they were not going to get one. After the Anden meeting, the City Engineer examined the remedial work Anden has done in River Oaks, and concluded that much less had been done than Anden had claimed.

Detectives Needed!

The River Oaks Board of Directors is trying to find some photographs of the area that is now River Oaks, taken before the subdivision was built. In Ordinance 828, the city wrote that Anden "shall compensate for landscaping removed" from the Common Area "by providing new landscaping similar to existing conditions." We hope that the lawsuit against Anden will result in enforcement of this ordinance, and hence we are trying to get photos of what the "existing conditions" were before Anden stripped the area bare of trees. If you are long-time residents of this area, or if you know someone who might have such a photo, please let any of the Board members know as soon as possible!

MINUTES OF RIVER OAKS FOURTH ANNUAL HOMEOWNERS MEETING

Johnson School - February 7, 1991

BOARD MEMBERS PRESENT: Karl Berland, Toni Oster, Gloria Langston, Linda Saxton, Amy Salyer, John Christiansen, Veronica Williams.

ABSENT: Bob Modene.

Meeting was called to order by Veronica Williams at 8:10 PM.

Veronica introduced Jim Kleinwachter who represents the West Branch Project of the Conservation Foundation of DuPage County. Their job is to restore and protect the river. This committee is restoring the water quality of the river and planting native grasses. They are very concerned with water quality so they have done 13 different tests on the water for various chemicals. At present the water quality is fair to good and does not pose a health hazard. Jim explained that his group has a program for schools to teach water conservation. They are also the watchdog of the river for dumping. He explained it is not a good idea to dump grass clippings in the river, as the chemicals are not good for the wildlife of the river. His group meets once a month and puts out a newsletter. Their next big project is the 33 miles of river cleanup on June 23 and 24. The whole month of June is River Month.

Veronica thanked Jim for his impressive presentation, and we will try to participate in the cleanup of the part of the river that flows along our subdivision.

Veronica introduced her husband Joe who talked on the property tax appeal. Joe stated that we will most likely see a reduction on our taxes as a result of the presentation he and Tom Sinnott gave to the tax review board. The final decision will not be known until April 15th. Also, most likely in the future we will be grouped with Fox Hollow instead of "old" Warrenville. If our taxes are not lowered we can go to the state and file an appeal, but we'd have to hire an attorney. We may be assessed each year, and we must be assessed every three years. Winfield Township uses the coun-

ty multiplying factor. Joe thanked everyone who helped in gathering the information that he and Tom presented.

Gloria presented the financial report (see below). The Financial report was done by Brian Hampton of Naperville.

The Groundskeeping Committee report was given by Cheryl Mahowald (see below).

Toni gave the Entertainment Committee report. She stated that it costs only \$0.73 per house per month to support her committee, and noted all the great things this committee did last year: the Easter egg hunt, Luau, and Halloween party. Toni had a great display on the wall with pictures from each event.

Amy Salyer gave a report on City Liaison.

Karl Berland gave the Beautification Committee report. He went over the easement planting and bulb planting. Karl thanked his committee people who had worked with him through the year.

John Christiansen presented the Newsletter Committee report. He thanked the committee members for their hard work, and all the homeowners who have contributed articles or announcements to the Newsletter. John pointed out a Newsletter Committee display of the over 80 pages of news which had been distributed to all River Oaks residents by the committee in 1990.

John also gave a report on the overall chronology and latest developments on the Anden issue.

Veronica took the floor again and said a few words about her time served on the board and mentioned that we had pretty much done all that we had set out to do three years ago - i.e., the entry way sign, upgrading grass in the Common Area, beginning planting in the entryway, easement planting, etc.

Veronica then introduced the three homeowners who were running for the three open positions: Cheryl Soelke, Millie Murphy, and Tom Sinnott. As there were no nominations from the floor, the motion to accept these three homeowners to the Board was made by Lois Hitchcock, and seconded by Amy Salyer. Approval was unanimous.

The Fourth River Oaks Annual meeting was adjourned at 9:45 PM.

The Winter Recovery includes pruning of bushes, minor seeding, overall clean-up of winter debris, removal of any downed tree branches, etc. A Cutting includes watering the entrance island with an application of liquid fertilizer, turning the soil around all trees and bushes, and removal of debris. The first of the four Weed and Feed Applications includes a pre-emergence to prohibit the growth of crabgrass and a fertilizer high in potassium to promote the growth of the root system.



MINUTES OF RIVER OAKS BOARD OF DIRECTORS MEETING

February 21, 1991

PRESENT: Veronica Williams, Toni Oster, Tom Sinnott, Cheryl Soelke, John Christiansen, Amy Salyer, Linda Saxton, Gloria Langston, Millie Murphy.

ABSENT: Bob Modene, Karl Berland.

The meeting was called to order by Veronica at 7:45 PM.

The minutes from the Annual Meeting were read and approved.

Treasurer: Gloria gave report. We received the bill from our attorney - we have presently paid him \$1400 for his services within the past year. We need to update our lien amounts on 2 lots. It was noted that all realtors will be notified when a house goes up for sale. We will inform them that there is an association and what the quarterly dues are. Also we will let them know who to contact when a letter is needed for closing, and that the letter will not be released if dues are not paid up-to-date.

At this time there is one house for sale that is behind one quarter in dues, and the new secretary will notify the realtor.

Gloria needs one more set of labels, and John will get her a set.

The new treasurer's stamp was ordered and received. Each bill will be stamped "net due 10 days" so there will be no misunderstanding about when the dues are owed. We need to contact our accountant to file Federal Form 1120H, which needs to be filed each year. Also, the Secretary of State needs to be called about our incorporation certificate to see if that needs to be renewed each year. The amendment passed at last year's annual meeting needs to be attached to the last page of the Bylaws, especially the copies that go to the new homeowners. Gloria will order new carbonless deposit slips from Gary-Wheaton Bank.

Veronica then opened the floor for nominations for officers. For President, John nominated Tom, who accepted; approval was unanimous. Toni volunteered for Vice President, Cheryl Soelke for Secretary, and Gloria Langston for

Treasurer; all were unanimously approved.

Committee chairperson assignments were not completely set at the meeting due to an unfilled vacancy (Fred Gervase's position) on the Board. However, the following assignments were agreed to: City Liaison, Amy; Entertainment, Millie; Newsletter, John; Nominating, Toni.

At this point, Tom, as the new president, took over the meeting.

Linda has offered to serve temporarily as liaison between the Board, the City, and Anden. She will not have any voting power and will either send a written report via the secretary or report directly to Board. This was accepted gratefully by the Board.

River Oaks is on the agenda for the Community Development meeting Tuesday, Feb 26th; John and Linda will attend.

John reviewed the current status of the situation between Anden, the City and River Oaks (see "Anden Update"). Copies of his phone conversations and a letter to Barry Moss from Joe Ricely were passed to Board members.

The City Engineer's report covers more details than our report; however, it doesn't include the retaining wall. Linda will compare our original complaint against the engineer's report to see what is missing. Apparently neither Anden nor the bonding company has responded to the City. In discussion of City Ordinance 828, it was decided that perhaps it would be helpful to obtain pictures of this parcel of land before it was cleared for development. Gloria will check with a resource to see if she can obtain some photographs. Linda will check with someone from the Historical Society to see if pictures are available also.

There are still vacancies for 2 committee chairpersons: Groundskeeping and Beautification. Toni will check with three individuals to see if anyone is interested in filling these positions. It was brought up by Veronica that although the Board prefers a committee chairperson to be a Board member, according to the Bylaws that person does not have to be a Board member.

A bid had been received and presented to the board from H & B for the 1991 groundskeeping work. It was decided to wait until a chairperson was found for groundskeeping to take action on the bid; however the bid within the budget and H & B did a good job last year, so it will probably be accepted.

A claim was filed in November on our liability insurance policy for an incident pertaining to the common area last summer. At this time we have not heard whether this claim has been settled.

It was agreed by all Board members that at this time we would resume receiving a financial report from the treasurer each month and it will be included in the minutes of the meetings and printed in the newsletter.

Dr. Street called from Johnson School to thank River Oaks for its generous donation of \$75.00 for use of the school for our annual meeting.

Finally, the River Oaks annual garage sale will be held on May 24 & 25. More details to come.

The meeting was adjourned at 9:55 PM.
