#### **NEIGHBORHOOD ALERT**

Sad to say, but in recent months there have been a rash of minor incidences in our neighborhood.

In late September a number of cars in the lower cul-de-sac (and one car on upper River Oaks Drive) were sprayed a type of pink aerosol, possibly the spray used to temporarily color hair. The police were notified and a report logged. Luckily damage was minor but one car had repairs of \$300+. Another incident report to the neighborhood watch occurred to a house by the easement sidewalk, of a homeowner who was alerted by dogs that someone was lurking around the house and may have even tried the front door for access, and even came back later. This was in the early to mid morning. Another incident of a small older red car whose driver actually knocked on a door of a homeowner asking for gas money, and finally an intruder who did go into a home (in December) and left muddy footprints in the carpet, but thankfully nothing was taken and the homeowners were not at home at the time. This is an appeal to re-activate our neighborhood watch program. We need block captains, at least 3, one upper, one lower, and possibly two more on the long stretch of River Oaks. These are disturbing to be sure, but we still have a very safe neighborhood. Anyone interested please call Linda Saxton, 393-2206. Also I encourage people to please call the police and have a report written, nothing is to minor, you may never know what's important. The police track these minor occurrences and can sometimes see a pattern, and will alert us to be on the lookout for things that have happened in other neighborhoods in Warrenville.

year contracts for the Common Area maintenance. Bob will look into moving the old subdivision sign to new location on or near the river bank. The Board agreed to buy bulbs to be planted in the entranceway areas, and John Christiansen volunteered to do the planting.

# Minutes Board of Directors Meeting

Date: January 7, 2002

Marnee called the meeting to order at 7:40 PM

Motion: Linda made a motion to accept the minutes as written. Marilyn seconded the motion. The motion passed.

**Treasurer's Report:** Marilyn suggested that the Board consider doing only one mailing for dues each year. This one invoice would have four tear-off forms to be returned with the four quarterly payments required on dates specified on the tear-offs. It would be the responsibility of the homeowner to send in the payments by the due dates. The Board agreed to this new billing method.

The Board will be filing one lien on a homeowner who is now delinquent by more than four quarters.

Becky made a motion to accept the Treasurer's report. Lois seconded the motion. The motion passed.

Entertainment: Lois reported that the Easter Egg Hunt is scheduled for Saturday, March 23, the weekend before Easter weekend. A committee meeting will be held to plan the event. Lois asked that the budget for Entertaining be increased by \$50 to cover this newly-added event.

#### City Liaison: No report

**Neighborhood Watch:** Linda will be looking into finding more block captains for the Watch. She will also be reporting on recent incidents in River Oaks in the next Newsletter.

Landscaping: Marnee received one proposal returned for the maintenance work in River Oaks. Brickmann, the current service that maintains the Common Areas, has offered a two year contract for \$7904 per year. This is an increase of \$232 per year over the previous contract. This figure does include the added task of maintaining the front entryway plantings. The Board agreed to accept this contract. Marnee suggested that the Landscaping budget be increased by \$50.

John Christiansen reported that he planted 950 bulbs in the entryway, a combination of daffodils and grape hyacinths, in the same color layout as the summer flowering perennials and shrubs that are planted there.

John also reported on the accumulated damage to the river bank due to the heavy rains in the spring and fall. The terraces are perfectly intact, but the spillway area under the stairs has suffered considerable erosion. He suggested that the Board attempt to get rip rap delivered from a stone company to be put under the stairs in order to stop the erosion. Becky made a motion to allocate an expenditure of up to \$300 for the rip rap, and Lois seconded the motion. The motion passed.

**Newsletter:** Linda will be working on the new River Oaks Directory. It was suggested to decrease the Newsletter budget by \$50.

#### **Old Business:**

**Entryway Lighting:** The Board agreed that there should be lighting of the entryway sign and would begin the project in the new fiscal year. The money for such a project would come from the reserve funds, rather than a dues increase.

#### **New Business:**

**Budget:** The Board drafted the following Budget for the fiscal year beginning on March 1, 2002. Dues are assessed by taking the budgeted amount of \$10,240 and dividing by 64 houses. The annual assessment will be \$160 per house, unchanged from last year, which can be paid in four quarterly installments of \$40 each.




# **RETURN OF THE EASTER HUNT !**
